A £5.00 Range Fee will be payable for each visit AND the first box of 50 .22 RF rounds will be provided free of charge. Any ammunition used thereafter will be charged at the Club rate. ALL AMMUNITION MUST BE STORED SECURELY AT THE CLUB UNTIL SUCH TIME AS A FIREARM CERTIFICATE IS GRANTED TO THE APPLICANT.

The Committee of the Club wishes to make clear to applicants that it is Club policy that a probationary period is to be completed before full membership of the club is established. This period will be as decreed by the Home Secretary at the time of application, or at the discretion of the Committee.

It is also to be understood that Club Rules and instructions given by an RCO are to be followed. Any misconduct can result in membership being terminated.

It is required by law that an Applicant's name and address is forwarded to the Norfolk Constabulary Firearm Section for record purposes.
